If you want to start a cooperative business or bring together a community group to address community problems, and you want to do this in a fair and democratic way, then get expert help and advice from PCDN

PCDN's offer includes :

Access to an online and in-person learning programme. This covers the enterprise and cooperative skills needed to run an effective co-operative, as well as specialist topics including community shares to finance a cooperative community business, and conversion to employee ownership as an option for business succession.

A dedicated 1-2-1 business advice service accessible via the PCDN's website. Two types of support are available: pre-technical support to answer initial enquiries and assess the suitability/viability of a business proposition as a cooperative enterprise; and, for those that meet this criteria, the provision of technical support from a business consultant to move the project from pre-startup through to the creation of a new co-operative enterprise.
